Instructions - Please Note:

1. The attached form **must** be used to nominate someone for the Vigil Honor.
2. A recent photograph of the nominee **must** accompany this nomination.  
You will be doing your nominee a disservice if you do not attach a photo. Do not assume That someone else will send in a photo or that everyone on the Vigil Selection Committee knows every nominee by name. A photo helps put a face with a name. Photos will not be returned.
3. The nomination form **must** be complete.  
Do not assume the Vigil selection committee is aware of all your nominee's accomplishments.
4. All nominations **must** be in by **October 1st**.  
All nominations will remain on permanent file by the Vigil Selection Committee for the current and one additional year.
5. To be eligible for the Vigil Honor, the nominee **must** have been:
  - a. a Brotherhood member in good standing for at least 2 years at the time of nomination,
  - b. currently registered and active with the Indian Nations Council, B.S.A., and
  - c. be currently registered (dues paid) and an active member of Ta Tsu Hwa Lodge #138, Order of the Arrow, B.S.A.
6. Remember: Keep this nomination confidential. The nominee **must not** have knowledge of his/her nomination for the Vigil Honor. A nomination does not mean automatic selection for the Vigil Honor. If selected, he/she will be notified only by the Vigil Selection Committee (currently recognized at the annual Lodge Banquet in a Vigil Call-out Ceremony).
